






Aim of establishment of the Energy Efficiency Fund

180 ths. multistory buildings




Increase of energy efficiency in the Ukrainian residential sector and reduce CO2 emissions. The direct beneficiaries of the EEF are homeowners associations and households.

Specific objectives of the action are:

- Modernization of the Housing Sector of Ukraine
- Additional investments in the economy
- Conservation energy resources
- Reduction of funding of subsidies for communal public services
- Reduction of gas consumption
- Reduction of CO2 emissions






Timeline of the Energy Efficiency Fund





EEF Program is focused on implementing energy efficiency projects in condominiums (HOAs)


Condominiums interact with the partner banks




Installation of IHS (weather regulation)




Measures of package «Light»

Replacement of windows (with the reconstruction of ventilation system if necessary)



Is to improve the quality of life and reduce the cost of utilities for building owners by supporting energy efficiency measures







Vision








In 2025, more than 2 million 582,000 families in 16,146 apartment buildings achieved an average energy savings of 20%, improved living conditions and received saving on utilities.










Strategy: main directions
