Legislation Development



PRIMARY LEGISLATION

- No new laws adopted (except Law on Electricity of Brčko District BIH – 28 Oct 2021)

SECONDARY LEGISLATION

- Amendments to the Tariff pricing methodology and New Market Code
 - SERC adopted the decisions on Amendments and the Market Code approval on 13 Oct 2021
 - Aligning with SO & EB Regulations + SAFA Agreement
- New Grid Code
 - Document drafted (31 May 2021)
 - ISO BIH submitted document for approval (29 Sep)
 - SERC requested adjustments & clarifications (13 Oct)
 - New version submitted for approval (23 Nov)

Documents Approved by SERC



- **Operational Agreement of LFC Block SHB**
 - ISO BIH completed its request for agreement conclusion approval (26 Oct 2021)
 - SERC adopted an affirmative decision (9 Nov 2021)
- **Rules for allocation of cross-border transmission capacities approved (17 Nov 2021)**
 1. Rules for annual and monthly auctions for...
 2. Rules for daily auctions...
 3. Rules for intraday...
 - ... allocation of transmission capacities at the border between trading zones of EMS and ISO BIH
 4. Rules for intraday allocation of transmission capacities on the border between control areas of HOPS and ISO BIH

Tariff Proceedings



- Tariff proceedings for transmission services
- Tariff proceedings for distribution services and supply within the universal service in the Brčko District of BIH initiated on 13 Oct 2021
 - Komunalno Brčko requested distribution annual revenue increase (6.75%) and supply tariff increase (6.2%)
 - Formal public hearing (10 Nov), no intervener
- Tariff proceedings for ISO services + system and ancillary services initiated on 9 Nov 2021
 - ISO BIH requested tariff for its services to be increased by 41% (G component) and 29% (L component); tariff for system service to be increased by 131.3% (excluding the cost of FCR)
 - Formal public hearing (30 Nov), five interveners

SERC Registers



- **SERC keeps the following online registers:**
 - Register of Licenses (ISO, transmission, distribution, supply and international trade activities)
 - REMIT Register
 - Register of Traders/Suppliers
- **International trade: 17 licenses**
 - During 2021, two licenses were renewed and two new (temporary) licenses were issued
 - “EZPADA” Mostar – license revoked at the request of the licensee
 - “LE Trading BH” Banja Luka – license suspended (9 Nov 2021) due to specific violations; revocation procedure ongoing
