





Kosovo Electricity Market




Installed/Available Capacity vs Peak demand

> 92% of generation capacity is from Thermal Power Plants (PP Kosova A and PP Kosova B) – Q1




January - March 2021

- > Actual generation is higher around 10% than forecast
- > Steady coal exploration and level of reserves is according to the plan
- > Around 37% of the energy is secured from import, whereas export is around 14%
- > Due to the state of emergency created by COVID 19 planed environmental upgrade

Transmission operations facts (1)

ENTSO-E Activities

- 14 December 2020 KOSTT has started to operate as Control Area in Control Block AK, under the synchronous area of Continental Europe.
- 5 October 2020 Kosovo's transmission system operator (TSO) KOSTT and its Albanian counterpart OST have signed the agreement on the establishment of the Albanian Power Exchange – ALPEX, formerly called APEX.

Transmission operations facts (2)

Network

- Strong interconnection Capacity/Peak=5794/1310=4.4
- Well Interconnected with neighbouring TSO-s (four 400 kV and two 220 kV lines)
- N-1 criterion is fulfilled for entire HV network
- Significantly reduction of ENS caused by transmission system
- Supporting industrial load growth and RES integration
- Transmission losses 1.27 % in 2020







Summer Outlook 2021 - Conclusions

- The situation of electricity supply in the Republic of Kosovo is stable, although KOSTT had some obstacles on crossborder capacities with the EMS where those interconnection lines (one 400 kV and one 220 kV) are blocked for commercial use, which effects negatively the Regional Market activities and also Security of Supply. The share of import last six month was about 15% and of export was about 10% compared to national consumption, the licensed companies have made all the necessary plans for sustainable supply of customers.
- > The Statement of Security of Supply for Kosovo was submitted within the deadlines, which includes all the requirements of the Energy Community.
- Regarding the state of emergency created by COVID 19, companies are implementing all instructions of the Government of the Republic of Kosovo to protect the health of employees at the time of the COVID-19 pandemic.
- Due to the state of emergency created by COVID 19 planed environmental upgrade of TPP Kosova B has been postponed in 2022-2023 (unit B2 2022 and unit B1 2023).
