# RECENT DEVELOPMENTS IN ENERGY SECTOR

### Recent developments October

- ✓ ERO Board in the meeting held in October:
  - has decided to open the tender process for Supplier of Last Resort.
  - has extended the license of TPP "Kosova A" and supply licence of "GSA";
  - has decided to publish the National Register of Market Participants, this action based on Article 7 (3) of the Rule on Integrity and Transparency of the Energy Wholesale Market (REMIT).



### Recent developments October

- ✓ ERO Board in the meeting held in October:
  - has decided to extend to the Supply Operator KESCO, the Obligation for Universal Service Supply, until March 31, 2022.
  - has approved the Maximum Allowed Revenues for regulated operators (Transmission System and Market Operator; Distribution System Operator and Universal Service Supply);
  - → has approved the application for Licensing of power generation from wind turbines, in a capacity of 34.47 MW;



## Recent developments October

- ✓ ERO Board in the meeting held in October:
  - has approved the electricity tariffs for the tariff year 2021, for the Transmission System and Market Operator, Distribution System Operator and for Universal Service Supplier.
  - has issued a license for electricity supply to the enterprise "HEP ENERGY";
  - has approved twelve (12) customer requests for installation of solar panels for self-consuming customers, in a total capacity of 284.66 kW;



### Recent developments November

- ✓ ERO Board in the meeting held in November:
  - has approved the Maximum Allowed Revenues for the District Heating "Termokos" in Prishtina, for the season 2021/2022;
  - based on the Maximum Allowed Revenues, the Board has decided to approve also the tariffs of DH "Termokos" for this season for the season 2021/2022;
  - has decided to issue Licenses for the production and distribution of thermal energy for the District Heating in Gjakova, and has approved the Ten year Development Plan (2022-2031) DH "Gjakova"
  - has approved one (1) customer requests for installation of solar panels for self-consuming customers, in a total capacity of 100 kW;



#### **Recent Developments**

- ✓ The Energy Regulatory Office has published for public consultation the Consultative Report on Input Values and Operating Expenses for the Universal Service Supplier for the period of 2022 - 2025;
- ✓ ERO has prepared and send it to the Parliamentary Commission the Working Plan for the year 2022
