#### Scope of the workshop

The European Commission in cooperation with the Energy Community Secretariat prepared adapted versions of:

- Regulation 2019/943 on the internal market for electricity (Electricity Regulation), Regulation 2015/1222 of establishing a guideline on capacity allocation and congestion management (CACM), Regulation 2016/1719 establishing a guideline on forward capacity allocation (FCA), Regulation 2017/2195 establishing a guideline on electricity balancing (EB), Regulation 2017/1485 establishing a guideline on electricity transmission system operation (SO), Regulation 2017/2196 on establishing a network code on electricity emergency and restoration (ER)
- as well as a draft Procedural Act on fostering regional energy market integration in the Energy Community

Following presentation of the adapted legal texts by the European Commission to the 63<sup>rd</sup> meeting of the Energy Community Permanent High Level Group on 20 April 2022, the Energy Community Secretariat distributed the documents for consultation by 16 May 2022.

The 1st technical workshop will provide explanations and clarifications on the adaptation concept, the envisaged geographic applicability, the legal basis and procedures as well as the further timeline.
