





Background – NECPs in the Energy Community

✓ Based on the Ministerial Council <u>Recommendation 2018/01/EnC-MC</u>

- prepare the analytical, institutional and regulatory preconditions for the development and adoption of integrated national energy and climate plans ('NECPs') for the period from 2021 to 2030;
- Energy and Climate Committee to coordinate and support the Contracting Parties in their efforts.

✓ Policy Guidelines 03/2018 of the Secretariat

- Guidance on the principles, scope, content, regional cooperation, progress reports and updates as well as the overall process;
- Aim: to ensure consistency among the NECPs and with the Governance Regulation.

✓ Upcoming developments

European Commission plans for introducing the Governance Regulation in the Energy Community in 2021.

Preliminary findings for consideration

✓ Give priority status to the NECP

- The NECP is the central policy document both the energy and climate areas;
- Align policies with / in the NECP;
- Hierarchy among & conscious time planning of the various strategies.

✓ Be integrative, comprehensive and consistent

- All energy related policies within the 5 dimensions should be included not exclusively those which relate to climate;
- > Do not mix objectives / desired outcomes with Policies and Measures (PaMs) + define PaMs concretely;
- Policies and Measures will overlap and will conflict with each other spot those cases and remedy them.

✓ Look into the future

- Define concrete targets broken down on sectoral level;
- Go beyond existing PaMs and take actual policy initiatives.



Preliminary findings for consideration (2)

- ✓ Substantiate your position on national contributions towards the Paris Agreement and future EnC targets by developing a sound analytical basis
 - The images of the future, namely reference- and policy scenario(s), should be plausible;
 - Assumptions should be comprehensively and clearly stated and internally consistent.
- ✓ Build up sufficient technical capacity
 - Historical inventories and future projections of GHG;
 - Modelling capacity for simulating the impact of policies and measures on future pathways.
- ✓ Set monitoring indicators on the status of implementation of policies and measures
- ✓ Consult regionally
 - Cooperation in elaborating and subsequent implementation is essential to improving the effectiveness and efficiency of measures and fostering market integration and energy security.
