

### **EBRD Loan for Security of Gas Supply**

- 300 milion EUR loan has been granted on 24th June 2022
- The amount is divided into two tranches: 100 + 200 m EUR with the purpose of Security Gas Supplies for Moldova
- Pre-payments for gas supplies will come directly from EBRD to supplier
- ENERGOCOM is the sole Moldovan commercial beneficiary of the loan
- ENERGOCOM had changed its structure, corporate governance and reporting procedures to follow strict criteria of EBRD
- Procurements will be conducted in a way of tenders for prequalified companies
- Prequalified companies (in alfabetical order): AXPO Ukraine, DXT Commodities, EP Commodities, ERU Europe, OMV-PETROM, PGNiG Supply and Trading, SNGT ROMGAZ



### **Development since May 2022**

- Opened a branch (sucursala) in Romania
- Registered and licenced trader of gas and electricity on Romanian market
- Registered member of BRM commodity exchange platform in Romania and Moldova
- During registration of user of TransGaz Romania infrastructure
- During registration of user of DepoGaz Romania storages
- Registered user of TSOUA Ukraine infrastructure
- Registered user of Ukrtransgaz Ukraine storages
- Registered user of RBP platform for capacity bookings



#### **Development since May 2022**

- most modern corporate governance structure among state controlled
   Moldovan companies implemented fully in line of EBRD requirements
- main partner for Energy Commission, Energy Community Secretariat,
   USAID, UNDP and EBRD in modernization of the natural gas market
- actively consulting the modernisation of Moldovan energy regulations
- conducted first in history backhaul / virtual reverse gas flow transaction on 28th of September (throughout IP Grybenniky from Moldova to Ukraine)
- building and sending to be stored gas stocks (in Romania and Ukraine UGS)
  which would secure ca. 30 days of full avarage consumption of the right
  bank of Moldova (excluding Transnistria) in October or full consumption
  avarage 10 days in January,
