Clean Energy Package II: 2030 energy and climate framework

- *Governance Regulation (EU) 2018/1999*
- *Renewables Directive (EU) 2018/2001*
- *Energy Efficiency Directive 2012/27/EU amended by (EU) 2018/2002*
- **Commission Delegated Regulation** with regard to values , amended by for global warming potentials and the inventory guidelines and with regard to the Union inventory system and repealing Commission Delegated Regulation (EU) No 666/2014
- **Commission Implementing Regulation** on structure, format, submission processes and review of information reported by Member States pursuant to Regulation (EU) 2018/1999 of the European Parliament and of the Council and repealing Commission Implementing Regulation (EU) No 749/2014

Clean Energy Package II:

- *Political consensus for adoption reached by the 2018 Ministerial Council on the 2030 energy and climate targets and the legislative package,*
- *Adoption envisaged at the Ministerial Council in November 2021;*
- *Two step approach to account for longer time needed to finalise the analytical background for the 2030 energy and climate targets.*

Clean Energy Package II:

Step 1:

- *Adoption of the full legislative package at the November 2021 Ministerial, however the legislative acts will not yet include the proposed energy and climate targets for the Contracting Parties of the Energy Community.*
- *Provisions in Governance Regulation, EED and RED, which do not depend on the energy and climate targets will be adopted as they are, but adjusted in terms of their timelines.*
- *Provisions which are directly related to energy and climate targets for the nine Contracting Parties will be adopted with provisional adaptations until the targets are established.*

Clean Energy Package II:

Step 2:

- *Adoption of the energy and climate targets, which will replace the provisional arrangements.*
- *In this way, the adoption of the legislative package will be secured, while maintaining the integrity of the Governance Regulation and coherence between the acts of the package.*
- *As a consequence, Contracting Parties will use their existing and forthcoming domestic RES, EE and GHG targets (such as those included in their NDCs) to kick off the implementation of Governance, RED and EED and inclusion as first step in their draft NECPs. These will be upgraded as soon as more ambitious targets become available.*

Clean Energy Package II:

2030 energy and climate targets:

- *The three targets, GHG, EE, RES, will be proposed as non-binding targets, and merits of the indicative contributions for each of the Contracting Parties can be considered after the results of the modelling study become available;*
- *The overall, collective targets for the Contracting Parties will be set as the sum of individual contributions;*
- *The revision of the legislative acts is being finalised and will be shared with the Secretariat this week;*
- *Discussions with the Contracting Parties at the next meeting of the Permanent High Level Group, possibly in Autumn 2021;*
