NON-LEGISLATIVE MEASURES

During the reporting period, the following projects have been implemented or are being implemented:

KEEREP - Implementation of EE Measures in Public Buildings, package 5 has been completed;

(EE Measures in 29 central public buildings, in the amount of 4.2 million EURO)

KEEREP- Implementation of EE Measures in public buildings, package 6. The tender has been announced;

(EE Measures in 12 central public buildings, in the amount of 2.9 mil. EURO)

Kosovo Energy Efficiency Fund has signed 73 Energy Services Agreements with 22 Municipalities.

(Projects expected to be completed within this year. The amount of the project is over 9 mil. EURO)

NON-LEGISLATIVE MEASURES

MCC/MFK - SEEK Project - Subsidies for Energy Efficiency in Kosovo, which includes the implementation of measures in private households and multi-apartment buildings. *(Around 980 grants were received in the amount of 50% -70%. The total value of this project is 9 mil USD)*

MCC/MFK - Project for installation of district heating meters and thermostatic valves to 17,500 customers of district heating in Prishtina; *(Project is ongoing: The amount of the project is 8.5 million EUR)*

"Implementation of Energy Efficiency Measures in Public Lighting" Reconstruction of the public lighting network in the Municipality Ferizaj and Kamenica; *(Project has comThe amount of 3.5 mil EUR)*

Monitoring and Verification Platform (MVP) has been completed with data from 15 municipalities;

The National Register is currently in the process of preparation. *(The software was developed by Fraunhofer and the latest changes are undergoing)*

INCREASE HUMAN CAPACITY

In 2021, 112 energy auditors were trained and certified by the Center for Sustainable Energy, operating within the University of Prishtina;

Training of 48 energy auditors is undergoing;

Working is ongoing to starting training and certification of energy assessors.

This month, within the framework of KEP/GIZ Project we have held 5 thematic workshops with stakeholders:

- Harmonizing the legal and regulatory framework for the Implementation of EE and RE in the building sector Of Kosovo;
- Financing of the implementation of EE and RE measures in the residential sector;
- Awareness Raising and Promotional Activities on EE and RES issues.
