TF1: Retail Market Monitoring





WS1: Market Monitoring Report on the functioning of gas and electricity retail markets in EnC CPs

- Three detailed questionnaires, prepared in the previous years for data collection, updated (electricity, gas and customer protection)
- NRAs to complete questionnaires by 29 April 2022
- Preliminary results to be discussed in June 2022
- WS2: Input to the annual market monitoring report of ACER/CEER on retail market and consumer protection developments
- EUROSTAT database would be used for breakdown of household prices based on retail offers
- WG agreed for ECS (ECRB Section) to share additional information, such as a number of suppliers, price regulation, billing, SoLR, vulnerable customers etc.

- Draft Agenda prepared, to be distributed for approval, the invitations will be sent consequently

 - Session 1 Clean Energy Package enhancement of consumer rights boosts the need for digitalization
 - Session 2 The future of heating on context with decarbonisation

TF2: Customer Protection (2/2)






WS2: Status review of implementation of consumer protection rules of the new Electricity Directive in the CPs

- DIRECTIVE (EU) 2019/944 of 5 June 2019 on common rules for the internal market for electricity
 - Incorporated and adjusted by the Decision of the Ministerial Council of the EnC of 30 November 2021
 - General implementation deadline: 31 December 2023
 - Part of the 'Clean Energy for All Europeans' package
- Detailed questionnaire prepared
- NRAs to complete questionnaire by 29 April 2022
- Preliminary results to be discussed in June 2022
- Focus on identifying the legal gaps to assist CPs in transposition and implementation

TF3: Quality of Supply





Joint CEER-ECRB benchmarking report on QoS

- Special TF established (Commercial quality, Voltage quality & Continuity of supply, Gas quality)
- Close contact with CEER (joint sessions of ECRB CRM WG and CEER QoS TF, numerous consultations)
- Delay in finalizing deliverables (pandemic, changes in the CEER drafting team)
- Inputs from EU Member States, Contracting Parties, Norway and Switzerland
- The drafting of the 7th Benchmark Report on Quality of Electricity and Gas Supply is ongoing, new chapters prepared, some NRA-specific comments to be clarified
- The paper should be ready for the CEER GA by summer 2022

TF4: NRAs' Public Outreach





Status review of public outreach tools employed by NRAs

- NRAs duties and responsibilities have substantial impact on the energy sectors, including customers
- Transparent and effective communication strategies needed to reach as many consumers as possible
- This task force shall investigate the outreach and communication strategies of NRAs with the aim to identifying best practices
- Questionnaire prepared, to be sent for completion
- Preliminary results to be discussed in June 2022
