### 2. Greening the energy sector - introduced and moderated by Ema Potocnik, Vienna International Arbitral Centre

One of the cornerstones to reach a climate neutral future is the decarbonisation of the energy sector. Some effects of the energy transition in the European Union, for example the pricing of CO<sub>2</sub> emissions have already started to spill over to the Contracting Parties of the Energy Community. A similar effect can be expected from the new rules under the EU Green Taxonomy Regulation. ### 3. **Greening the buildings sector** - introduced and moderated by *Violeta Kogalniceanu, Energy Community Secretariat*

In order to make the region's economies truly energy efficient, the countries need to harvest the potential for increasing energy efficiency in the building sector, as the largest final energy consumer with approximately 43% of total energy consumption and an energy saving potential as high as 40%. Nevertheless, the amount of investments needed exceeds by far the current rate of deployment. This section will look into the implications of the EU Taxonomy on the buildings sector and provide some possible greening options.
