Mr. Besnik Aliaj

Rector, Polis University, Albania

Mr. Aliaj is Co-founder, and current Rector of POLIS University. Lecturer of 'Urban Design' and 'Regional Planning' courses. 16-years academic experience as lecturer of Urban Design at the Faculty of Civil Engineering, Polytechnic University of Tirana, and head of the Urbanism Department (2003/5). Graduated as Architect – Urban Designer (1990) and later on postgraduate studies in Real Estate and Property Evaluation (1994/95 in Polytechnic of Tirana). Master in Urban Management (1996) at Urban Management Center (IHS & Erasmus University, Rotterdam Netherlands).

Mr. Nicolò Rossetto holds a PhD in Economics, Law and Institutions from the Institute for Advanced Studies of Pavia (IUSS).
