

PROPOSAL FOR RE POLICIES AND MEASURES

June 2021: 11th RECG meeting - Discussion and proposals on suitable zoning for NECP PaM

Regional system for the Guarantees of Origin













1. Establish a national Electricity GO registry in each domain:

- GOs transferrable among the Energy Community domains
- Fulfills EECS, RED, CEN requirements
- Extendable to all energy sources and energy carriers later

2. Training and Knowledge transfer:

- Registry access opened at the start of the project (after 1st training)
- Train all competent bodies as proficient registry users before go-live
- Train other users of the system (future Account Holders)
- AH & IB knowledge transfer beyond what is strictly necessary
 - GOs, residual mix, disclosure, markets, EECS DP

3. Continuation framework after project:

- o Developed national registries will be kept ready until June 2023
- Raas agreement for all competent bodies after the project
- o any updates from EECS and CEN are covered without extra price

4. Prepare for AIB Membership:

- o Compatibility and hub connection maintenance guarantee
- Enables a stepwise approach for international transfers



Introduction of market based support scheme

Energy Community Secretariat keeps supporting Contracting Parties in design of market-based support schemes.
