

Minutes of the 44th ECRB Meeting

4 December 2019, 09:30-17:30

Premises of the Greek Regulatory Authority (132 Pireos Avenue, Athens)

1. Opening

The ECRB President welcomed the ECRB regulatory authorities' participants as well as Mr Akhundov, representing the regulatory body of Azerbaijan. Mr Pangani also welcomed Director Kopac and thanked the Energy Community Secretariat for the invitation to the ECRB Christmas dinner on 3 December. He further thanked RAE-Greece for hosting the 44th ECRB meeting and confirmed the presence quorum necessary for ECRB decision making.

Mr Radheshi updated on ongoing REMIT working group developments and presented the proposal for a work program of the REMIT WG in 2020.
