





DATA GATHERING ON **BUILDING RENOVATION PROGRAMMES**

- EnC Secretariat plans to publish the 1st Western Balkans Energy Transition Report with the long-term objective to support and facilitate energy transition;
- Focus of the first report: findings on the implementation of a short-term objectives (by 2020) in energy efficiency, renewable energy, climate and environment, electricity market:
- Assessment of the current situation: using a combination of quantitative/qualitative assessment;
- Further plan is to use the information gathered on EE in buildings to use in proposing new legislation, NECP preparation and other support measures.





BUILDING RENOVATION IN NATIONAL EE ACTION PLANS

- Most CPs have submitted their last **NEEAPs** (at least draft versions);
- All CPs have some EE measures for the building sector (focusing on public sector);
- However some reports are lacking detailed quantitative reports on the EE measures in buildings;
- Some already started to draft new NEEAP measures in buildings > however they should be included in NECPs as of 2021.

BUILDINGS RENOVATION INVESTMENT PROGRAMMES - OVERVIEW

- Several international donor open databases have been used for data gathering:
 - KfW, WB, EBRD, USAID, EU, GGF, etc.
- Following main categories were assessed:
 - Amount and type of finance;
 - Type of intervention;
 - Level of intervention:
 - Type and number of buildings affected;
 - Energy efficiency and emissions reduction gains.
- Large number of programmes were found, however available data varies significantly.



BUILDINGS RENOVATION INVESTMENT PROGRAMMES – GAPS

Mostly missing information are:

- Planned or actual end of the programmes;
- Number of buildings affected;
- Planned or actual energy savings;
- Planned or actual emissions reduction.


