#### **PROSUMERS**

- ✓ Board of ERO on the meeting held in October has approved Power Purchase Agreement for self-consumption and the invoice (bill) for this category of consumers;
- ✓ ERO has prepared a draft Rule for Prosumers, and it is in the finale stage to put in the public consultation;
- ✓ From the last ECRB meeting Board of ERO, has reviewed and approved nine (9) requests for self-generation, with a total capacity of 290.82 kW;
- ✓ Total ERO decisions for issuing the status from regular customer to Prosumer.

### **MONITORING**

- Board of ERO has reviewed and approved the monitoring reports of:
  - Distribution System Operator Compliance Program (KEDS);
  - Capital Investment Monitoring Report for Transmission System and Market Operator (KOSTT) and for Distribution System Operator;
  - Consumer services for DSO and the Supplier;

 Upon review and approval of Monitoring reports for licensees, ERO Board has prepared and send to the licenses specific recommendations to improve services to consumers, where these recommendation are line with our primary and secondary legislation.



## **OTHER DEVELOPMENTS**

- The Board of ERO has issued three temporary (1 year) licenses for the production of electricity for hydropower plants, HPP "Deçani", HPP "Belaja" and HPP "Lumbardhi";
- Board of ERO has approved the Maximum Allowed Revenue (MAR) for "Termokos" District Heating Company (DH) for the regulatory year 2019-2020 and also the retail prices for consumers.
- Board of ERO has approved the Maximum Allowed Revenue (MAR) for "Gjakova" District Heating Company (DH) for the regulatory year 2019-2020 and also the retail prices for consumers.
- Board of ERO has approved request from DH Gjakova for granting final Authorization for construction of new Heating Plant and cogeneration unit with biomass.



# **Cooperation with other institutions**

- Energy Regulatory Office of Kosovo and Energy and Water Services Regulatory Commission of Republic of North Macedonia on 19<sup>th</sup> November 2019 have signed the Cooperation Agreement.
- By the signing of this cooperation agreement, both Regulators have agreed to work closely together in these areas: regulatory policies in the energy sector that are not confidential; monitoring licensed energy activities and developing performance reports; methodology of determining tariffs for energy activities, construction of new RES generators and instruments of support of RES projects; and other relevant information, in order to enable staff from both institutions to learn from each other's experiences.
