Energy Transition TF overall objective

- ❖ The overall objective is to analyse the DSO related requirements of the CEP and actively contribute in the consultations on adoption and adaptation of the CEP in order to ensure that obligation imposed on DSOs can be met in a timely and efficient manner.
- ❖ An important aspect from DSOs point of view is to govern the communication and participation of the ECDSO-E in the EU DSO Entity with the aim to lead the cooperation with this Entity, to improve the knowledge and to build capacities for implementing the CEP obligations.

Activities planned in accordance to the Working Program

- **Analysis of the New Electricity Market Rules** (The [Directive on common rules for the internal market for electricity](#) (EU) 2019/944, which replaces Electricity Directive (2009/72/EC), and the new Regulation on the internal market for electricity (EU) 2019/943, which replaces the Electricity Regulation (EC/714/2009) on January 1 2020) **with the focus on**

- the traditional roles of the DSOs. In particular, how the traditional roles of the DSOs are changed by the Directive 2019/944 and Regulation 2019/943 taking into consideration the peculiarities of the legislation of each EC Contracting Party.



Analysis of the the traditional roles of the DSOs. In particular, how the traditional roles of the DSOs are changed by the Directive 2019/944 and Regulation 2019/943

Members of the Energy Transition TF:

- Analyzed the traditional roles of DSO under their respective primary legislation in comparison to
 - Electricity Directive (2009/72/EC)
 - Electricity Directive (EU) 2019/944
 - Electricity Regulation (EC/714/2009)
- Created the respective comparison table of the legislation for each EC CP

On 08 of June the EU DSO Entity has been officially established.

The status of non-EU DSO are still not defined.

The Energy Community is in the process of communication with European Commission on possible ECDSO-E participation in the Entity.

Till the end of July 2021 – development of short slide – main outcomes of the abovementioned analysis.

As of September – start of the analysis of the emerging roles of the DSO under Clean Energy Package (continuity - 4 months)

It is for the consideration of the Members of the Energy Transition TF to decide later on the form of the report of the whole analysis to be done in 2021
