About the topic: About the topic: NREAPs, NECPs., NECPs... These abbreviations refer to national energy plans, which have become more encompassing and integrated over the years. The plans envisage a comprehensive framework of policies and measures for achieving different goals and targets related to energy, environment and climate. How did the governance of these national plans change in the European Union and the Energy Community? What if one country does not implement adopted measures, or fails to achieve the targets? What are the means of enforcement of national energy plans and targets? In their presentations, Biljana Grbić and Lisse van Vliet will aim to answer these questions, focusing on the national Renewable Energy plans and targets, as well as enforcement instruments that can be used for ensuring achievement of the set national goals.

About the speakers: Biljana Grbić is a qualified lawyer, with LL.M. in European and International Business Law and more than seven years of diverse experience in the energy field and enforcement proceedings. In particular, she gained work experience in the judiciary, district heating company, the Ministry of Mining and Energy of the Republic of Serbia and the Energy Community Secretariat. Currently, she is working on the project "Heating and Cooling Network" in the Secretariat.

Lisse van Vliet is currently working on gas market liberalization and integration at the Energy Community Secretariat. Lisse has extensive experience in the SEE region, having studied in Russia, carried out research in Ukraine and having started his professional career at Dutch Embassy in Azerbaijan. For his Post-Graduate Degree at the College of Europe, he wrote his dissertation on the change in Renewable Energy governance in the EU and the Energy Community.
