Policies under development

- **National Energy Strategy of the Republic of Kosovo 2022-2031**
(In the approval process)
- **Energy Strategy Implementation Action Plan 2022-2024**
(In the drafting process)
- **Concept Document on Energy Efficiency;**
(Draft is finalized and will be published soon for public discussion)
- **Law on Energy Performance of Buildings;**
(Draft will be launched soon on preliminary discussion)
- **Plan to Increase the Number of NZEB-2022-2024;**
(in the working group stage/MESPI is supported by GIZ)
- **Building Renovation Strategy**
(A Building Renovation Strategy draft will be reviewed after the Energy Strategy 2022-2031 is approved)

- **National Energy and Climate Plan**

- The revision of NCEP will start after the approval of the Energy Strategy
- Obligated decarbonization targets are expected to be approved in the Ministerial Council in the Energy Community on 15 December 2022 and will serve as a basis for the revision of the NECP draft.
- We are waiting for the approval of the RES Law, which creates the basis for transposing of the Governance of the Energy Union and Climate Action, in the basis of which will be determined the new structure for the continuation of the NECP drafting process above the basis of the working draft.

- **Fiscal measures for EE**

REEP Plus is assisting the Ministry of Economy on developing a fiscal scheme for energy efficiency measures

Eco-design and Energy Labelling

Eco-design and Energy Labelling directives will be transposed on the secondary legislation

Energy Performance Certificate/ National Register

The National Register is currently in the process of preparation. Software was developed by Fraunhofer and the latest changes are undergoing. Trainings for energy assessors are in process. 4 sessions have been held.

Energy Auditors

In 2022, 48 energy auditors were trained and certified by the Center for Sustainable Energy, operating within the University of Prishtina;

NON-LEGISLATIVE MEASURES

Subsidies for energy efficiency measures for households

The Ministry of Economy last month has launched subsidies for efficient heating systems such as heat pumps, heat inverters (air to air), biomass boilers and individual biomass stoves.

MCC/MFK - Project for installation of district heating meters and thermostatic valves to 17,500 customers of district heating in Prishtina;

(Project is ongoing: The amount of the project is 8.5 million EUR)

KEEREP-Implementation of EE Measures in public buildings, package 6

(Project includes EE measures in 12 central public buildings, in the amount of 2.9 mil. EURO)

Kosovo Energy Efficiency Fund has signed 73 Energy Services Agreements with 22 Municipalities.

(Projects expected to be completed within this year. The amount of the project is over 9 mil. EURO)
