






Legal framework

- Law on Commodity Reserves
- Energy Law
- + all necessary by-laws are in place, ERP under preparation

Plans:

- Long-term plan & Mid-term plan for gradual forming and maintaining of the compulsory reserves;
- Action plan is one of the benchmarks for opening discussion on Chapter 15-Energy
- Action plan for implementation of the Directive 2009/119/EC-drafted
- Received and answered on questions by EC
- EC gave green light to combine draft of the AP and given answers and to submit it again
- as per their opinion the draft AP is ready to be adopted by the government



➤ Progress after 1st year of operations

- Administration for reserves of energy generating products closed first operating year with following results:
 - Products
 - 16.000 t crude oil
 - 24.200 t Euro Diesel
 - 3.000 t Motor gasoline
 - 5.000 t Heating oil LS –s

- Call option agreements Tickets
 - 48.000 t Euro Diesel
 - 12.000 t Motor gasoline

• presented amounts are equal to 14,4 days of average consumption, we managed to reach almost 90% of allocated budget in 6 months





Projects, investments, next steps 1/2

- IPA 2015 Technical assistance to the Administration for reserves of energy-generating products concerning the optimal management of mandatory oil stocks project approved ToR in preparation
- IPA 2016 Oil and oil products Storage project proposal preliminary rejected by EC
- Investments in new and reconstruction of existing storage capacities, plan for 2016.:
 - 2x 20.000 m³ storage for oil products in tendering process
 - VRU system for one existing terminal in tendering process



Projects, investments, next steps 2/2

- > "NESO" (National Emergency Strategy Organization) under preparation
 - Emergency Response Plan is funded by the EU through the Project PLAC (Policy & Legal Advice Centre)- planned deadline for the adoption Q3 2016.
 - ➤ Working group established for close cooperation with experts from PLAC project will become permanent NESO
 - ➤ Administration will operate also as secretariat of NESO
