cross-border transactions are not subject to the transmission and dispatch tariffs in Ukraine as of 01 January 2024.

GAS

- Existing PSOs on natural gas market prolonged 15 April 2024
- GSO "Naftogaz of Ukraine" appointed (without a tender) as supplier of 'last resort' for the whole riod of martial law and within 6 months after
- Neutrality fee on gas market now to be applied by Gas TSO starting from 2024/2025 gas year base on monthly balancing results.

JOINT X-BORDER CAPACITY ALLOCATION

Q3

Regulatory framework for start of joint capacity allocation or borders between Ukraine and EU Member States approved in Ukraine. For UA-RO border joint allocation platform is Ukrenergo, for UA-SK, UA-HU, and UA-PL = JAO. Joint auctions on UA-RO border started since 2 November 2023.

GAS TSO CORPORATE REFORM

Started with the adopted Law # No 3293-DL GTSO moved under the control of Ministry of Energy. The new charter of GTSO approved respecting the Binding Opinion of the Secretariat. The candidates for the Supervisory Board agreed by the Governmen

REMIT IMPLEMENTATION

Started timely: NEURC adopted first three acts regulating registration of wholesale market participants, investigation procedure and methodology for calculation of penalties for narket abuse. The registration of WEM participants started i mid October 2023.



DELAY IN TRANSPOSITION OF ELECTRICITY MARKET INTEGRATION PACKAGE EXPECTED

Required amendments to the primary legislation of Ukraine still at the drafting phase. The Secrtariat calls for action on NEMO designation till December 2023 and provides support in drafting the relevant draft law.



DECARBONISATION AGENDA



The Secretariat organised a Business-to-Business Forum in Vienna on renewable gases and H2 in September 2023 - how to unlock untapped biomethane potential in Ukraine:

- the Customs Code amended in March 2024
- the establishment of the Register is still pending

STORAGE TARGETS AND NEW TEN – E REGULATION

- ECS adopted the decision on filling targets on 13 November 2023
- Intermediate gas storage filling targets were met and fulfilled in 2022, 2023 and February 2024



*For Ukraine, the filling target is reduced to 35% of its average annual gas consumption. Thus, the intermediate targets of the filling trajectory shall be reduced accordingly by 35% multiplier

- The Energy Community Secretariat has released its annual report on the implementation of the Storage Regulation
- The new TEN E Regulation adopted in the Energy Community, for PECI projects only no eligible projects









REGULATORY ISSUES - ECRB in 2023



- Analysis of the Consultation Document on the **Gas Transmission Tariff Structure for Moldova** Revision based on more accurate capacity and revenue forecasts recommended
- Annual report on contractual congestions at interconnection points of the EnC CPs
- Contractual congestions on IPs not identified









- Position on setting the level of the multipliers used for the calculation of gas transmission tariffs applied for daily and within-day standard capacity products
- Full implementation of the Tariff Network Code recommended


