
# 10:00 – 11:00 High-level panel: What Does a Just Energy Transition Mean for the Energy Community?

The stage has been set for the clean energy transition. The Western Balkan Contracting Parties pledged to follow the European Union in its decarbonisation path towards a carbon neutral economy by 2050 under the Sofia Declaration on the Green Agenda. A decarbonization roadmap for 2030 and beyond for the Energy Community is currently being developed alongside national strategies and actions, including National Energy and Climate Plans (NECPs). What measures are the Contracting Parties taking to ensure that the energy transition is just and its benefits are dispersed among all regions and citizens? What tools are available to support this process?

# 11:00 – 12:00 Panel I: An Inclusive and Just Energy Transition: Breaking out of Energy Poverty

Energy poverty is a prevailing problem in the Energy Community Contracting Parties and needs to be placed at the forefront of decarbonisation efforts. A just transition must ensure that basic energy services to the vulnerable and poor are guaranteed. The Contracting Parties already employ a number of measures to protect vulnerable customers, but are these designed to reduce energy poverty in a sustainable way and in the long-run? This session will explore innovative policies and practices to tackle energy poverty and unveil insights uncovered by an Energy Community Study on the current level of deprivation and tailor-made policy recommendations.
