# Aim of the Confernce



Dear Participants,

I am very happy to welcome you all to the annual Energy Community Investment Conference in Vienna. This year's topic is THE SUSTAINABLE ENERGY SUPPLY CHALLENGE. Keeping in mind that sustainability, together with affordability and competitiveness of energy supply are pillars of the European energy policy, the Energy Community is keen to contribute to these through its efforts.

Please allow me to start by quoting the European Union's (EU) Energy Commissioner, Günther Oettinger, "To be a successful economy, we need sufficient, reliable, affordable and sustainable energy supplies. Energy is the fundamental element in our growth and is defined by many as the lifeblood of our economy".

The Energy Community is committed to the same ambitious objectives in the field of energy as the EU. Towards this end, the Community is looking to integrate the greenhouse gases response into national energy planning, e.g. by supporting renewable energy, closing or retrofitting less efficient power plants, implementing stricter rules on generation technologies for new power plants, and, last but not least, developing energy efficiency policies to curb demand growth.

As you all know by now, the Ministerial Council adopted the list of Projects of Energy Community Interest



at its meeting of 24th October this year. This is indeed an important step in a long process: from plans to implementation. Nevertheless, we can only be satisfied when a significant number of these projects have been realized, and energy supply has become not only more secure, but also more affordable and sustainable.

The Conference debate on the "future" of gas in the Energy Community, the coordinated development of gas networks and gas fired power plants in the Energy Community, brings together the most important European industry associations (Eurelectric and Eurogas), private investors, Multilateral Development Banks, incumbent electricity and gas companies, as well as policy-makers. Together they will look for answers to key questions, such as: how to best use national natural resources, without putting at risk our sustainable future;





how to develop and grow continuously, while using less energy per unit of output; how to attract investments in energy infrastructure in times when national public budgets are facing significant financing constraints, and more...

Investments in new and more efficient, environmentally friendlier capacities have great importance for the Energy Community, especially at present times when climate change concerns have reached the top of the agenda in more and more administrations, and the energy markets expand from national to regional and even global ones.

While developed and integrated energy markets are key factors to success, an enabling environment for investments will help to build the much needed infrastructure that sustains consumption growth.

By reducing regulatory barriers to investments, introducing innovative financing mechanisms, and using the numerous financing facilities recently set up by the International Financial Institutions and the European Commission, many investments started and will continue to materialise- in the power and gas industries, the manufacturing sector, as well as in public buildings and municipal services.

Nevertheless, we should keep in mind that energy consumption and economic growth could be "de-cou-

pled" successfully, and one of the key answers is energy efficiency!

In parallel, the sustainable energy supply, reducing the carbon footprint of the energy sector, and use of environmentally friendlier technologies will remain high on the Energy Community's agenda.

I wish you all successful and constructive discussions on these important issues.

# **Opening Speech:**



Mr. Fabrizio Barbaso

### Deputy Director - General, the European Commission, Belgium

Mr. Fabrizio Barbaso has a background education in law. Born in Torino, he started his professional activities working for a multinational group in Italy. He joined the Commission in 1976, where he occupied several positions in the services in charge of internal market and industry. He worked for 9 years directly with two Italian Commissioners in various capacities in their cabinet before heading the unit in charge of textile, clothes, furniture, leather and footwear in the Internal Market Directorate. In 1997, he was appointed Director in the External Relations Directorate dealing with the countries of Southern Europe (including the Balkans), the European Economic Area and Switzerland.

2000 - 2003, he was in charge of market policies as Deputy Director General in the DG for Agriculture. At the time when ten countries joined the European Union (2003 - 2005), he was acting Director General of DG for Enlargement. This was followed by a position as Deputy Director General of DG for Transport and Energy in charge of coordination of the energy policy (2006 - 2010). He holds his present position since January 2011 and is in charge of the external dimension of the energy policy and the development of new financial instruments.

He began his vocational career in a steel mill in Nikšić (1977-1996). Mr. Čanović holds a Master degree from Faculty of Electrical Engineering, Podgorica.

Founder of the ECA (1997), Mr. Tomkins is an economist with extensive experience of economic analysis and modelling, focussing on energy issues in the gas and electricity markets. Previously a Director of London Economics and Director of Environmental Resources Management (ERM), Mr. Tomkins's career also includes lecturing in the Management School at Imperial College, London, where he taught MBA students and directed energy policy research.


